Resolution #2018-03 to extend term of Ordinance No. 2010-07 pertaining to Parks Township, that expanded the improvement area boundaries to be included in the tax abatements for property tax on certain commercial, industrial, retail or other business property under LERTA for an additional ten (10) year period retroactive to September 21, 2016 for an extension of the established LERTA Zone from September 21, 2016 until September 21, 2026.

On a motion by Mr. Renshaw, seconded by Mr. Skamai and carried unanimously, the Board of Commissioners, based on the recommendation of Mr. Palilla, adopted Resolution #2018-03 to extend term of Ordinance No. 2010-07 pertaining to Parks Township, that expanded the improvement area boundaries to be included in the tax abatements for property tax on certain commercial, industrial, retail or other business property under LERTA for an additional ten (10) year period retroactive to September 21, 2016 for an extension of the established LERTA Zone from September 21, 2016 until September 21, 2026.
