On a motion by Mr. Skamai, seconded by Mr. Renshaw and carried unanimously, the Board of Commissioners, based on the recommendation of Ms. Johnson, approved the 2014 and 2016 CDBG Cooperation agreement between Armstrong County and Kiskiminetas Township for the Jackson Drainage Area Phase IV Sanitary Sewer Project.

2015 CDBG Cooperation West Kittanning Municipal Authority

On a motion by Mr. Skamai, seconded by Mr. Renshaw and carried unanimously, the Board of Commissioners, based on the recommendation of Ms. Johnson, approved the 2015 CDBG Cooperation agreement between Armstrong County and West Kittanning Municipal Authority for the Arthur Street and North Crescent Avenue Water Line Replacement Project.

I.E. Power LLC
