On a motion by Mr. Skamai, seconded by Mr. Renshaw and carried unanimously, the minutes for the December 1, 2016 Commissioners' Meeting were approved.

RESOLUTION

Resolution #2016-34 Transit Coordination Study

On a motion by Mr. Skamai, seconded by Mr. Renshaw and carried unanimously, the Board of Commissioners, based on the recommendation of Mr. Palilla, adopted Resolution #2016-34 Transit Coordination Study.

AGREEMENTS / CONTRACTS

Family ACTS, Inc.

On a motion by Mr. Renshaw, seconded by Mr. Skamai and carried unanimously, the Board of Commissioners, based on the recommendation of the Prison Board, approved the agreement between Armstrong County and Family ACTS, Inc.

9-1-1 Statewide Interconnectivity Funding

On a motion by Mr. Renshaw, seconded by Mr. Skamai and carried unanimously, the Board of Commissioners, based on the recommendation of Mr. Baustert, approved the Statewide Interconnectivity Funding agreement between Armstrong County and Pennsylvania Emergency Management Agency PEMA.

Kukurin Contracting, Inc. Change Order #4

On a motion by Mr. Skamai, seconded by Mr. Renshaw and carried unanimously, the Board of Commissioners, based on the recommendation of Ms. Johnson, approved change order #4 between Armstrong County and Kukurin Contracting, Inc. to decrease the construction contract for the Ford City Borough Water Treatment Plant Project in the amount of \$3,423.

Tim Fouse Excavating

On a motion by Mr. Skamai, seconded by Mr. Renshaw and carried unanimously, the Board of Commissioners, based on the recommendation of Ms. Johnson, approved summary change order between Armstrong County and Tim Fouse Excavating, to decrease the overall project cost from \$14,765 to \$13,885.70 due to existing field conditions, fewer materials/labor were required to do the work.

Senate Engineering Company

On a motion by Mr. Renshaw, seconded by Mr. Skamai and carried unanimously, the Board of Commissioners, based on the recommendation of Ms. Johnson, awarded the Professional Engineering Contract for engineering design and part time construction inspection services for the School Street Reconstruction Project to Senate Engineering Company in the amount of \$4,800.00.

Change Order #3 I.E. Power, LLC.

On a motion by Mr. Renshaw, seconded by Mr. Skamai and carried unanimously, the Board of Commissioners, based on the recommendation of Ms. Johnson, approved Change Order #3 between Armstrong County and I.E. Power, LLC.

Senior Service America, Inc.

On a motion by Mr. Skamai, seconded by Mr. Renshaw and carried unanimously, the Board of Commissioners, based on the recommendation of Ms. Talerico, approved the SCSEP Sponsor agreement modification, extending period through January 31, 2017, between Armstrong County and Senior Service America, Inc.

Personal Emergency Response System Services
