It is **ORDERED, ADJUDGED and DECREED** that all charges filed against the Defendant in the above-captioned matter by the Attorney for the Commonwealth be dismissed.

#### PART III

It is **ORDERED, ADJUDGED and DECREED** that the aforementioned keepers of criminal records shall expunge and destroy the official and unofficial arrest records and other documents pertaining to the arrest or prosecution or both of the above-named Defendant in the above-captioned criminal proceedings, and that each shall request the return

of such records which its agency made available to State or Federal agencies and immediately upon receipt thereof shall destroy such records, with the exception of District Attorney's records concerning ARD, which shall be used solely for the purpose of determining subsequent eligibility for ARD and Pennsylvania Department of Transportation records which shall be used solely for tracking prior DUI convictions, and that said keepers of such criminal records shall file with this Court an affidavit stating that the mandates of this Order have been fulfilled.

It is **ORDERED, ADJUDGED and DECREED** that the Clerk of Courts shall expunge the indices of the official and unofficial arrest records and other documents pertaining to the arrest or prosecution or both of the above-named Defendant in the above-captioned criminal proceedings, and shall seal and impound the aforesaid affidavits together with the Indictment, the Complaint and the original and all copies of this Order and no person or agency shall be permitted to examine such documents.
