- a. **14293** Action on the recommendation to approve the reassignment of Stephen Daub from full-time Caseworker I to full-time Caseworker II at \$17.03 per hour effective March 7, 2024, due to obtaining his Bachelor's Degree and successful completion of one (1) year of service and all the necessary requirements for certification of a Direct Service Worker per the SEIU Collective Bargaining Agreement. Caseworker II salary would become effective retro to January 1, 2024.
- b. **14294** Action on the recommendation to approve a temporary salary adjustment of \$3.00 per hour from \$11.09 per hour to \$14.09 per hour for full-time Clerk Typist Kathryn Medeiros effective retro to February 5, 2024, due to the fiscal technician position remaining vacant since May 2023 with Ms. Medeiros temporarily assuming these responsibilities in addition to her assigned responsibilities and dependent on the Teamsters Union agreeing to the adjusted rate. This is temporary until the vacant fiscal technician position is filled. CYF has funds available in the budget for this temporary increase.
