

**COMMISSIONERS' ELECTED OFFICIALS' SALARIES
PUBLIC MEETING**

October 24, 2018



THE ARMSTRONG COUNTY BOARD OF COMMISSIONERS' ELECTED OFFICIALS' SALARIES HEARING PUBLIC MEETING WAS CALLED TO ORDER ON WEDNESDAY, OCTOBER 24, 2018 AT 6:31 PM IN THE COMMISSIONERS' CONFERENCE ROOM WITH THE FOLLOWING IN ATTENDANCE:

Commissioner Pat Fabian, Commissioner Jason Renshaw, Commissioner George J. Skamai, Aaron S. Poole, Chief Administrator, Marianne Hileman – Register and Recorder, Amanda Hiles – Treasurer, Brian Myers – Coroner, William J. Rupert - Sheriff

Mr. Fabian announced that this meeting was not being recorded.

PUBLIC ANNOUNCEMENT

Commissioner Fabian announced that the purpose of this meeting is to fix the salaries of elected officials and he read aloud Pennsylvania statute 16 P.S. 11011-10.1 in its entirety.

He noted that per Pennsylvania statute 16 P.S. 11011-10.1 #1, the notice of this meeting was published October 12, 2018 in the Leader Times, which is a subsidiary of "Trib Total Media".

PUBLIC COMMENT

The Commissioners fielded questions and offered clarification in regards to the mandated action that was being discussed. In reponse to a request, the commissioners offered the current salaries for the county's elected officials as follows:

a) Coroner	<u>\$44,119.50</u>
b) Sheriff	<u>\$59,150.62</u>
c) Commissioners	<u>\$65,745.42</u>
d) Register & Recorder	<u>\$63,818.04</u>
e) Prothonotary	<u>\$63,818.04</u>
f) Treasurer	<u>\$59,150.52</u>
g) Controller	<u>\$59,150.52</u>

On a motion by Mr. Skamai, seconded by Mr. Renshaw and carried unanimously, in accordance with Pennsylvania Statute Title 16, Chapter 4, Article XV (A) P.S. §11011-10.1 (2005), The Armstrong County Board of Commissioners agreed that all Elected Officials Salaries shall be increased annually at the same rate of increase which will be determined by the then current Board of Commissioners for non-bargaining unit County employees.

This action will be taken by way of resolution at the November 1, 2018 Public meeting and shall apply to all County elected officials effective January, 2020 with the exception of the District Attorney whose salary is set by legislation with a separate Act.

On a motion by Mr. Renshaw, seconded by Mr. Skamai and carried unanimously, the Commissioners moved to adjourn the Public Meeting at 7:00 PM.
