Motion was made by Ms. Gaff and seconded by Mr. Renshaw to table. Motion carried unanimously.

PAF 13063 was moved by Mr. Renshaw and seconded by Mr. Fabian to recreate a full-time Administrative Assistant I position at Non-Supervisory Pay Grade 9 (\$11.28 to \$14.72 per hour) effective August 5, 2021. (Reassignment on PAF 13057) Motion carried unanimously.

PAF 13070 was moved by Mr. Fabian and seconded by Ms. Gaff to recreate a casual part-time Recycling Specialist position at \$15.00 per hour effective August 5, 2021. (Voluntary resignation on PAF 13029) Motion carried unanimously

PAF 13070 was moved by Mr. Fabian and seconded by Ms. Gaff to approve the hiring of Sean Evans-Arblaster to a casual part-time Recycling Specialist position at \$15.00 per hour effective August 5, 2021, pending successful completion of pre-employment screenings. Motion carried unanimously.
