

**MINUTES OF THE SALARY BOARD MEETING HELD ON

The Armstrong County Salary Board Meeting was called to order by Commissioner Donald K. Myers at 9:00 a.m. in the Commissioners' Conference Room.

PAF 13703 was moved by Mr. Renshaw and seconded by Ms. Miller to recreate a full-time Corrections Officer position at \$16.00 per hour effective December 21, 2022, per the Teamsters' Collective Bargaining Agreement. (Termination on PAF 13702) Motion carried unanimously.

PAF 13705 was moved by Mr. Fabian and seconded by Mr. Renshaw to approve the return/reassignment of Kody McConnell from temporary full-time Lieutenant at \$25.75 per hour to full-time Corrections Officer at \$16.53 per hour (current rate) effective December 21, 2022, as per a fully-executed Memorandum of Understanding as agreed upon by the Teamsters and United Steelworkers. Mr. McConnell resumed his previous position as of November 27, 2022. Motion carried unanimously.

PUBLIC DEFENDER – James Spriestersbach

PAF 13707 was moved by Ms. Miller and seconded by Mr. Renshaw to create a part-time Administrative Assistant I position at Non-Supervisory Pay Grade 9 (\$11.28 to \$14.72 per hour) effective December 21, 2022, per the Teamsters' Collective Bargaining Agreement. Motion carried unanimously.
