**PAF 14697** was moved by Ms. Gaff and seconded by Mr. Strate, to create a full-time Property Appraiser position at \$19.00 per hour effective February 20, 2025, per the SEIU Collective Bargaining Agreement. Motion passed 3 to 1. Mr. Fabian opposed.

**PAF 14713** Human Resources Manager, Audrey Campbell announced that Mr. Montebell has requested to have this item withdrawn. No motion made, no action taken.

#### CHILDREN, YOUTH & FAMILIES - Paula McClure

**PAF 14699** was moved by Ms. Gaff and seconded by Mr. Strate, to approve the hiring of Megan Shea-Beattie to a full-time Caseworker position at \$19.00 per hour effective February 20, 2025, pending successful completion of pre-employment screenings and per the SEIU Collective Bargaining Agreement. (Created on PAF 14133) Position start date will be February 20, 2025. Motion passed 3 to 1. Mr. Shea abstained

#### JAIL – Warden Hicks

## **PUBLIC DEFENDER – Elizabeth Christopher**
