PAF 14858 was moved by Mr. Pitzer and seconded by Mr. Fabian, on the recommendation to recreate a full-time Deputy Sheriff position at \$18.00 per hour effective July 17, 2025. (End of assignment on PAF 14857) Motion carried unanimously.

BELMONT – Gary Montebell

PAF 14869 was moved by Ms. Gaff and seconded by Mr. Shea, to approve the reassignment of Samuel Wylie from a full-time Maintenance Worker I at \$12.19 per hour to a full-time Maintenance Worker II \$12.94 per hour effective July 17, 2025, per the Teamsters' Collective Bargaining Agreement. PAF 14856 was moved by Mr. Shea and seconded by Ms. Gaff, to recreate a full-time Corrections Officer position at \$18.00 per hour effective July 17, 2025, per the Teamsters' Collective Bargaining Agreement. (Voluntary resignation/retirement on PAF 14855) Motion carried unanimously.

PAF 14862 was moved by Mr. Shea and seconded by Ms. Gaff, to recreate a full-time Lieutenant position at \$27.32 per hour effective July 17, 2025, per the United Steel Workers Collective Bargaining Agreement. (Voluntary resignation/retirement on PAF 14861) Motion carried unanimously.

TAX REVENUE – Richard Farah

PAF 14864 was moved by Mr. Shea and seconded by Ms. Gaff, to create a full-time Assessment Department Clerk II position at Non-Supervisory Pay Grade 6 (\$9.74 to \$12.71 per hour) effective July 17, 2025, per the Teamsters' Collective Bargaining Agreement. This position is being created due to a restructuring of the Tax Revenue department and will abolish the action taken on PAF 14768. Motion carried unanimously.

PAF 14871 was moved by Mr. Shea and seconded by Ms. Gaff, to create a temporary casual parttime Review Specialist position at \$19.00 per hour effective July 17, 2025. This position will assure that Tax Revenue has appropriate coverage as the new assessors are training prior to them attaining their own license to a Certified Pennsylvania Evaluator. Motion carried unanimously.

PAF 14872 was moved by Mr. Shea and seconded by Ms. Gaff, to approve the hiring of Veronica Zeigler to a temporary casual part-time Review Specialist position at \$19.00 per hour effective July 17, 2025. (Created on PAF 14871) Position start date will be July 1, 2025. Motion carried unanimously.

PAF 14875 was moved by Mr. Shea and seconded by Ms. Gaff, to create a full-time Tax Claim Supervisor position at Supervisory Pay Grade 8 (\$26,383.50 to \$34,417.50 per annum) effective July 17, 2025, per the Teamsters' Collective Bargaining Agreement. (Reassignment on PAF 14810) This position is being created due to the reorganization of the Tax Revenue department. This will abolish the action taken on PAF 14845. Motion carried unanimously.

VOTER REGISTRATION – James Webb

PAF 14870 was moved by Mr. Shea and seconded by Ms. Gaff, to approve the hiring of Kaitlin Dombroski to a full-time Office Manager position at \$34,417.50 per annum (Step J) effective July 17, 2025, pending successful completion of pre-employment screenings.
